- Completion of Program:** This option may be used only one time. The student is graduating during the current term and needs only _____ credits to complete the degree requirements. The last course can be an online or live or hybrid course taken at Illinois Tech and not at another institution.
- Graduate Students Taking Qualifying/Comprehensive Exam:** This option may be used only one time. The student is taking the qualifying/comprehensive exam this semester/quarter and will be registered for 6 credits. The student must enroll full-time during all subsequent semesters of coursework, even if the exams need to be repeated.
- Graduate students working on a degree REQUIRED project:** The student is either completing all coursework this term and is also working on a REQUIRED project or has already completed all coursework and is only working on a REQUIRED project. The student must be enrolled in at least one special problems credit hour (594 or 597) each term until completion of the program.

Appointment REQUIRED with an International Student Advisor for approval of the following reasons:

- Academic Difficulties:** This option may be used only one time. The student must be enrolled in at least 6 credits. The following circumstance applies (please select only one):
 - Difficulties with English language or reading requirements in the first term of study in the U.S.
 - Unfamiliarity with American teaching methods in the first term of study in the U.S.
 - Improper course level placement (in this instance, students are allowed to drop a course *only* when the advisor had recommended for a student to take a course for which he/she was not academically prepared.)
- Medical Condition:** Cannot accumulate more than 12 months of Reduced Course Load exemption for this reason per academic program. The student has shown a letter from a licensed US medical doctor/clinical psychologist that he/she should take a reduced course load/refrain from taking courses during the current term. Please attach the letter to this form.
